I understand that at any time period prior to the completion of the Pilot, MassCEC will have the right to audit my or my agents' records to confirm the 2022 Total Income of all members of my household as reported to the Internal Revenue Service. MassCEC or the Commonwealth of Massachusetts or any of their duly authorized representatives shall have the right, at reasonable times and upon reasonable notice, to examine and copy at reasonable expense, the books, records, and other compilations of data pertaining to my household's 2022 Tax Returns. Such access may include on-site audits, review, and copying of records. If such audit reveals my 2022 Total Income was outside of the bracket reported on this form such that I received a higher incentive for the Pilot than I was eligible for, then I shall refund to MassCEC the amount of incentives I was ineligible for as determined by such audit within thirty (30) days of my receipt of such audit and demand.
