
# Act Creating A Next-Generation Roadmap for Climate Policy

#### \$12 MILLION ANNUALLY TO EXPAND MASSCEC'S WORKFORCE DEVELOPMENT EFFORTS

In 2021, the MA Legislature passed the Act Creating A Next-Generation Roadmap for Climate Policy setting aggressive net zero emissions goals for 2050 and interim goals and officially recognizing the inordinate impact climate change has on Environmental Justice (EJ) Neighborhoods and other marginalized communities.

Within the Act, the Legislature set aside \$12 million annually to enable MassCEC to expand its workforce development efforts to support individuals living in EJ Neighborhoods, Minority- and Women-owned Business Enterprises in Clean Energy Sectors, and Fossil Fuel Workers transitioning into the sector.

In 2022, the Legislature expanded the applicability of the Act to also include members of Federally Recognized and State Acknowledged Tribes, as well as members of those populations currently underrepresented in the Clean Energy Sector.





# **Targeted Minority- and Women-Owned Business Enterprises**

#### MWBE ARE 51% OWNED AND DOMINANTLY CONTROLLED BY MINORITY OR WOMEN PRINCIPALS

- May have MA, federal or other city specific certifications in place
- ► May have the ownership structure in place to gain certification but need assistance
- ► May need support to create a business entity that would be able to gain certification once established
- ► May be an early-stage start-up with minority founders in executive roles, regardless of equity stake or demographics of other shareholders





# **Targeted Environmental Justice Populations**

#### INDIVIDUALS RESIDING IN ENVIRONMENTAL JUSTICE NEIGHBORHOODS OR LOW-INCOME COMMUNITIES

An EJ Neighborhood has one or more of the following four criteria:

- Annual median household income not more than 65% of the statewide annual median;
- Minorities comprise 40% or more of the population;
- > 25% or more of households lack English language proficiency;
- > 25% or more are minorities and the annual median

household income is 150% or less of the statewide median.

# **Examples of Targeted MWBEs within Climate-Critical Sectors**



#### **ELECTRICAL CONTRACTORS**

Minority sole proprietors or small electrical contractors exploring expanding into EV infrastructure, solar installation, or building retrofit



A startup in the blue economy supply chain with minority founders and executives seeking incorporation and subsequent certification



#### **RETROFIT CONSULTANTS**

Minority or women owned consulting services working in energy audits that need assistance with MWBE certification



#### **HVAC CONTRACTORS**

A larger HVAC general contractor that is minority owned that needs back office administrative support to enable growth into the heat pump sector and certification to better access contracts

#### **GENERAL CONTRACTOR**

Minority or women owned general contractor with experience retrofitting buildings that needs guidance on applying for and landing larger scale building retrofit contracts

#### **ENGINEERING CONSULTANTS**

Minority or women engineers seeking to expand their consultant practice and gain access to highly competitive procurement pipelines

#### **SOLAR INSTALLERS**

Solar installers that are women or minority owned and seeking assistance with capacity growth and recruiting assistance



#### **EV CAR SHARE COMPANIES**

EV car share startup company founded and owned primarily by women seeking access to capital to expand service area

# Who is eligible to apply?

Partnerships are strongly encouraged and may be looked upon more favorably to the extent that partnerships can provide a range of expertise and experience to deliver a comprehensive proposal. One party should take on the role of leading the application team ("Lead Applicant").

# The following types of entities are eligible to serve as Lead Applicant:

- Non-profit organizations including Chambers of Commerce, trade associations, clean energy incubators/accelerators, EJ organizations, and organizations representing tribes;
- Academic institutions with a business support program; or
- For-profit entities such as clean energy installers, energy efficiency or home performance contractors, technical or workforce organizations, financial institutions, or other clean energy practitioners

- Lead Applicant must have a MA-based office or staffing;
- Applicants are not required to have experience in clean energy or climate critical business fields; and
- This funding is not intended to benefit a single MWBE.

#### Target Sectors/Demonstration of Market Opportunity

- Defined climate critical businesses to focus on substantiated with data
- Strong ties to workflow and customers, so MWBEs have a pipeline of work available at completion
- Identifies current gaps in services and has a plan to fill gaps
- Target MWBEs clearly identified

#### Program Design and Completeness of Statement of Work

- Comprehensive training plan with vocational and work readiness curricula
- Outreach and program elements tailored to specific segment of MWBEs
- Design and delivery allows capture data and continuous improvement
- Reasonable timelines and concrete milestones to track
- Specific goals and/or target outcomes for success
- Role of partners / subcontractors clarified

#### Budget/Cost

- Competitive cost per MWBE relative to services proposed

# Leveraged Resources and Long-term Success

- Proposal leverages existing MWBE support and workforce resources
- Leverages match funding (optional)
- Existing resources (human and financial) to complete the project
- Proposed project will continue to benefit MWBEs beyond the grant funding

#### **Diversity of Approaches**

- Team diversity applicant teams are diverse, including SDO certified partners
- Geographic diversity consideration for a spread of communities, variety of climate critical business fields, and diverse project plans
- Sector diversity consideration for variety of high priority climate critical business sectors
- Heightened and Innovative Support not offered by other programs addressing childcare barriers, food/housing insecurity

# Strand A: Training, Certification, and Support Services for Climate-Critical MWBEs

Award Range: \$250,000-\$1,000,000 Award Duration: 1 Year – 3 Year Award \*

Scalable Impact – Not intended to benefit a single MWBE; to support an organization that can help several different MWBEs grow and excel in climate critical business sectors

A Comprehensive Support Plan – Tailored to the specific needs to best support MWBEs and effectively address specific barriers to success and integrated into program design and budget

 Geographical Reach - Identified need for support initiatives in several regions including within the Central, Northeast, and Southeast Workforce Skills Cabinet Regions

\*an additional year of post-program monitoring and metrics tracking is required after the proposed project is complete, so applicants should plan and budget for that obligation.





# **Program Design**

- Applicants present a comprehensive program design with specific services, strategies, and training offerings that align with their stated goals for supporting MWBEs.
- Applicants match outreach, engagement, and program design elements to the needs of the specific segments of MWBEs that they aim to serve.
- The program design and delivery are organized to maximize benefit to the supported MWBEs and to allow the support organization to effectively capture data outcomes to continuously improve programming.
- The program design includes a reasonable timeline and concrete milestones with specific goals and/or target outcomes to trach progress and these milestones are reflected in the payment schedule and budget.

# Strand A Program Design

#### SUCCESSFUL APPLICATIONS WILL INCLUDE.....

Milestone(s) that indicate successful completion for MWBEs (offramps)

- Attainment of industry recognized certifications/ licenses
- Case management that successful removes barriers for organizations

Maximizing impact by addressing both "Supply" and "Demand" needs

- <u>Supply</u> working with MWBEs to ensure that they are certified by the Massachusetts Supplier Diversity Office
- <u>Demand</u> educating stakeholders how best to access procurement opportunities for certified MWBEs

Description of plans to engage relevant partners to provide additional services

Clear delineation of services best equipped to offer internally, and which ones to offer through partnership, and which services can only be offered through referral to other organizations






### **Program Example – Partner Roles**

# Strand B: Access to Capital for Climate-Critical MWBEs

Award Range: \$50,000-\$250,000 Award Duration: 1 Year – 2 Year Award \*

Approach – Funding will support programming to increase access to capital for climate-critical MWBEs, without distributing funds directly to individual MWBEs.

Investment in Ecosystem - To best address barriers to capital, organizations will coordinate MWBE Support Grant Awardees and MWBEs to develop a shared approach to increasing access to capital

Strategy Development – Awarded projects shall result in a final recommendation mapping out solutions to funding gaps

\*Programs only proposing a single-year program are less likely to be competitive for the maximum funding award.





# **Strand B Additional Selection Criteria**

# **Program Design**

- Applicants present a clear workplan with distinct and detailed steps taken during each stage of the program, including research, stakeholder engagement, development of resources, and drafting of the final recommendation.
- Applicants provide a reasonable staffing plan for the work proposed with assigned roles and responsibilities for the proposed tasks.
- The workplan design engages organizations currently funded under the MWBE Support Grant program and the participating MWBEs in those initiatives.
- The program design defines a reasonable reporting process and continuous improvement plan.

# **Strand B Additional Selection Criteria**

# **Program Impact**

- Applicants present a reasonable preliminary vision of funding solutions and collaborations that would address existing gaps in access to capital by climate-critical MWBEs.
- The preliminary vision takes into account MWBEs of different scales and proposes how to adequately leverage, administer, and monitor a portfolio of mixed stream funding sources.
- The proposed number of MWBEs receiving direct education as part of the initiative appears reasonable relative to the funding requested.

#### SUCCESSFUL APPLICATIONS WILL INCLUDE.....

- Analysis of Available and Applicable Funding Resources
  - Research and Identification of resources
  - Determination of Eligibility Criteria and Application Processes
  - Education and Training, including tailored content, for climate-critical MWBEs
- Engagement of Ecosystem Stakeholders
  - Engagement of existing MWBE support grantees
  - Using engagement to tailor resources to meet the needs of climate-critical MWBEs
- Development of Mechanisms for the Distribution of Funds
  - Plans to streamline the qualification of MWBEs
  - Processes to administer mixed funding streams
- Preparation of a Final Recommendation for Addressing Gaps




# Clean Energy Internship Program Summer Session open now!
